Question 1: How does the group define high school internships?

Discussion notes

- Experience invaluable
- soft skills to be responsible, employability skills, communication skills; give them a chance to create think
- ability to know how to give feedback
- exposure tackle the unknown
- value that their thoughts are
- learn from them
- opportunity for students
- opportunity for employers
- community builder
- bridge to careers and opportunities for students
- overall the opportunity to streamline students into potential, future careers at the same time as providing businesses a direct pipeline to future workforce
- also post high school before post secondary
- time span when students learn about business/organization over time (not just 1 time tours/shadow)
- may or may not include lots of responsibility; experience is important
- clearly defined goals and jobs for students to do
- make student realize their own value (and capability) to the company
- gives opportunity to break cycle
- \$500 stipend doesn't mess up parents' benefits

Question 2: Review the child labor laws. Thoughts?

- it's a lot and very specific; no gray area
- shouldn't work before 7AM or after 11 PM but some students do
- employers call students at school
- students should be educated on their rights
- students/parents should set healthy boundaries
- a lot of restrictions
- certifications to permit more access to restricted jobs
- we can't change these laws, we just live with them
